Call to Order:

Chairman Ward called the NFPD Board of Directors Meeting to order at 6:01 p.m.

Pledge of Allegiance:

• VC Jordan led the Pledge of Allegiance.

Roll Call:

 Chairman Ward present, Vice- Chairman Jordan present, Secretary Elder present, Director Sprouse present and Director Egge present.

Discussion/Information/Action

- Request for Recognition/Petition for Certification of Newcastle Professional Firefighters Association
 - Chairman Ward read the request aloud. ATTACHMENT 1
 - o Director Sprouse asked if we are big enough to support a union.
 - O Director Egge stated that we are a small department in a small town and that he had hoped common sense would have been used and the Board spoken to directly if there are issues. He further stated that the people on the petition are out of their depth and should be mindful of the public image. This creates the image that they want more which will ultimately harm the Department as a whole.
 - Chairman Ward stated that the Newcastle Firefighter Volunteer is not tied to the proposed new association in any way, shape or form. Also, the legal expense for this will be high. The documents needed for the trailer contract cost \$6k.
 - Diana Vanetta asked if any other Placer Co. Departments are unionized.
 - Chairman Ward stated that there are.
 - Jerald Saladana asked if they can do this because Newcastle is an unincorporated town.
 - Chairman Ward stated that they can.
 - Chief Randy Smith stated that it is much easier to deal with a union because you are able to negotiate with one person. This does not mean you are opening up your checkbook.
 - John Downs stated that the District is in trouble and this has just slapped everyone in the community in the face.
 - Director Egge stated that he has a lot of faith in the Firefighters.
 - o Bill Monihan stated that they want more big government.
 - o Glenda Freeman stated that FLSA defines the hours FF's work. Can unionization change FLSA?
 - Heater Pier stated that she belongs to a union herself and that employers have the option to hire union workers or scabs. Does the District have that option?
 - Chief Carr stated that there is not an MOU in existence. An MOU should have been the starting point for this.
 - Director Sprouse stated that he is surprised this has come up. He thought we were on the road to recovery.
- Review and Adopt POL-00031_N/C, Records Retention Policy
 - VC Jordan stated that according to the Clerk, the District does not have a Records Retention Policy in place. This policy will define when records may be destroyed.
 - Secretary Elder made a motion to adopt POL-00031 Revision N/C as presented. Director Sprouse seconds the motion.

 - Request NFVA to fund 1 or 2 good CPR mannequins for advanced skills.
 - Chief Carr stated that Loomis Fire has offered to loan us equipment.
 - Investigate the possibility of acquiring a smaller rescue vehicle to respond to EMS calls. It woild have 1 practitioner and 1 Volunteer or Resident on board.
