- a. Consider a request from Ms. Mahaffey-Raty to exempt Measures F and B from her property APN 042-225-010-000.
 - i. After much board discussion, Secretary Heisterkamp made a motion to deny Ms. Mahaffey-Raty's request and directed the Fire Chief to ask Gill to send a letter to Ms. Raty on how to combine parcels. Director Bettencourt seconds the motion. Motion carries unanimously via roll call vote (3/0).
- b. Consider and approve the Appropriations (GANN) limit of \$1,883,073.81 for FY 2023-2024 as prepared by the Placer County Auditor-Controller. Secretary Heisterkamp made a motion to approve the GANN limit as presented. Director Bettencourt seconds the motion. Motion carries unanimously via roll call vote (3/0).
- c. Consider and approve staff to submit an application for a USDA Community Facilities Grant for equipment not to exceed \$100,000.00. The district's share not to exceed \$50,000.00.
 - i. Director Bettencourt reported that the grant would be used to buy a fuel vault for station 41.
 - ii. Secretary Heisterkamp made a motion to approve the submission of a grant application with the district's matching share not to exceed \$50k. Director Bettencourt seconds the motion. Motion carries unanimously via roll call vote (3/0).
